Re-Invitation for Electronic Bids

1. Ministry of Health, Department of Health Services (DoHS), Logistic Management Division (LMD), Teku, Kathmandu re-invites electronic bids from eligible bidders for the Procurement of **Anti Rabies Vaccine (300,000 Vial)** to be delivered at the Central Medical Store, Teku under international competitive bidding.
2. Interested eligible bidders may obtain further information and inspect the Bidding Documents from the Logistics Management Division (LMD), Teku, Kathmandu on GoN official working days between office hours or, may visit e-GP system: www.dohslmd.gov.np/egp.
3. Bidding documents is available online and can be download from e-GP system: www.bolpatra.gov.np/egp. Interested bidders shall register in the e-GP system and deposit the cost of bidding document in the following bank.

4. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provision stipulated in the Bidding Document.
5. Electronic Bids must be submitted to the Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal through www.bolpatra.gov.np/egp on or before **12:00 Hour** on **28 February 2018**.
6. Bids shall be opened in presence of Bidders' representatives who choose to attend on **13:00 Hour** on **28 February 2018** at the office of Department of Health Services, Logistics Management Division, Teku, Kathmandu, Nepal. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of **NPR. 1,800,000.00** or the equivalent in a freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period (**i.e. valid up to 27 June, 2018**).
7. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. In the case of discrepancies or error in bid documents, bid notice or any other document, the DOHS reserves the right to amend and correct at any time.
9. DOHS reserves the right to accept or reject wholly or partly or all bids without assigning any reason whatsoever.
